4. There are additional extras available, however these are not included in the basic package and incur additional charges.
5. The prize is as stated and no cash or other alternative will be offered.
6. If there is not sufficient room for our basic setup, then the actual setup may vary in accordance to available space.
7. The event times will be 19:00-00:00. We will ensure we are ready prior to the start time and finish at the stated time.
8. We can normally be set-up within 45 minutes, depending on the venue. Please allow us sufficient time to enter the venue to set-up and sufficient time to pack away.
9. It is the winner's responsibility to clarify, with the venue, what time the venue has to be cleared. If this is before 00:00 then the finish time will be adjusted to meet the venues requirements.
10. The start time can only be adjusted under exceptional circumstances and at the discretion of Blu Ice Roadshow.
11. Once the date has been agreed by the winner and Blu Ice Roadshow, this can only be changed with a non-refundable deposit of £100.00.
12. Your details will be held securely by Blu Ice Roadshow and used exclusively by us; we may occasional contact you with offers, for feedback and following up enquires.
